Such certificates may be purchased from the city. The placement or use of private mausoleums at the cemetery is prohibited.
3. Hold discussion regarding the number of urns per niche in the columbarium in Sec. 22.010. Interments (f) The maximum number of placements per columbarium niche is one cremation.
