In addition to the opportunity citizens have to express their thoughts at City Council Meetings and public hearings, San Marcos citizens also may apply to serve on one of many Boards or Commissions . The descriptions on the Volunteer Brochure are intended to convey a general idea of the duties and requirements of service on these boards and commissions. Membership on these boards commissions are open to all San Marcos citizens. Unless otherwise noted, the only requirement for service is that the applicant must live in San Marcos.
